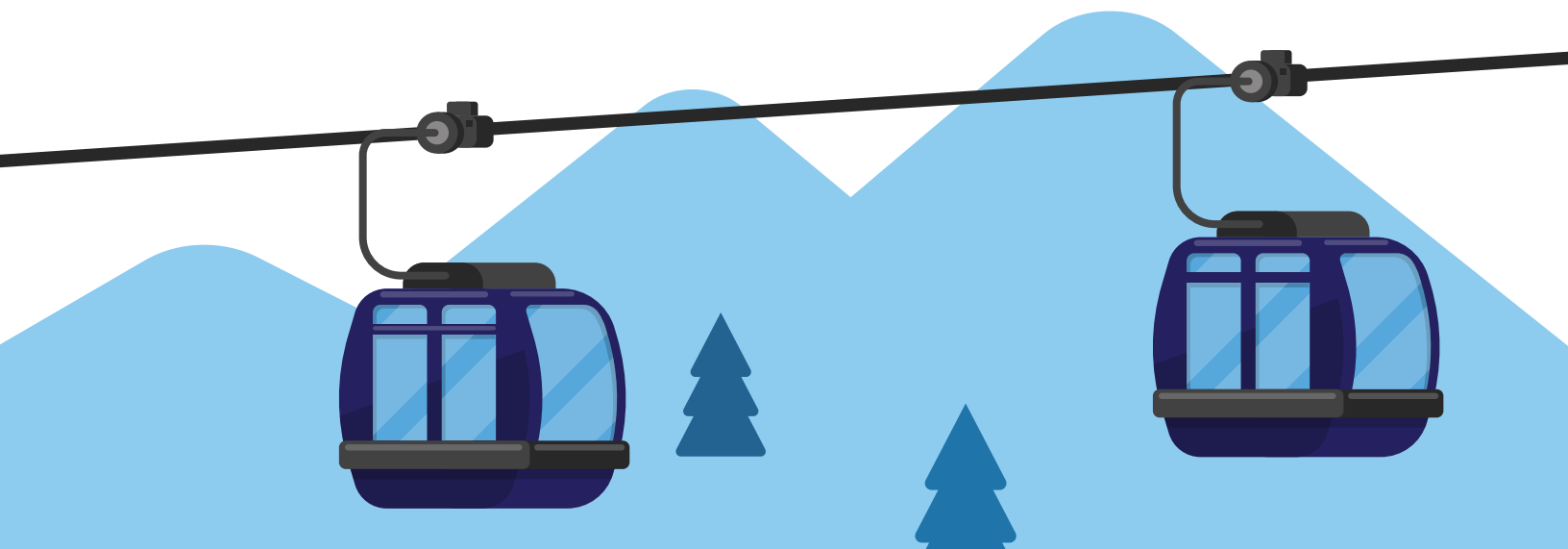

Overview



Our ski pass kiosks allow customers to purchase, or pick up an online purchase, in only a matter of seconds.

Our kiosks have been designed so resorts can sell ,either, label tickets or RFID cards. (If you are not currently using an RFID system, but plan to in the future, you will not have to purchase a new kiosk)

If you are using an RFID system, our kiosks will also allow customers to reload their previously purchased passes.

Labels

Botrow kiosks dispense thermal labels, for non RFID resorts. In order to guarantee compatibility, we require the labels be purchased from us.

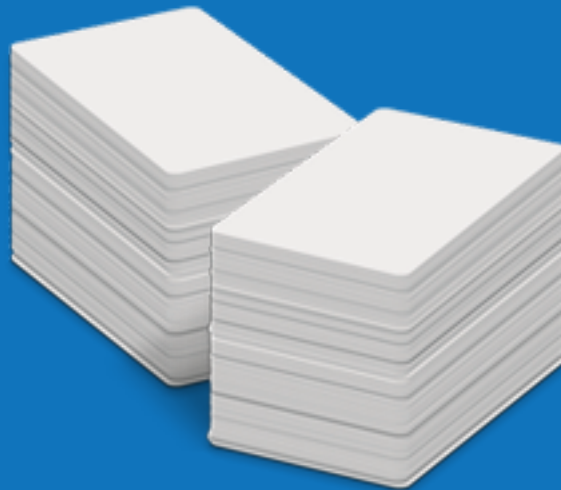


Pass Options



RFID Cards

Botrow kiosks also dispense thermal re-writable RFID cards. We can dispense both HF and UHF cards.



Fraud Protection



If your resort is concerned about customers buying cheaper lift tickets than which they are eligible (i.e. an adult buying a student pass), we can implement a system where the buyer needs to scan their provincial identification card in order to purchase a pass at a reduced rate.

This feature is not a must, and from the data we have collected over the years, it doesn't appear that people are abusing the system.



Integration



Botrow kiosks can integrate with your POS system as long as the company who developed your POS is open to integration.

Some clients choose not to integrate because they like the idea of their kiosks working if their POS system goes down.

There are positives and negatives to both, but we can go whichever route you would like.



System Requirements



- Secure Internet Connection (wired)
- Power Outlet (120v/60Hz)



Data Collection



Botrow Kiosks can track the name, age, gender, and address, of customers, when the fraud protection system is implemented.

We can also track how many times a week/month/year a person visits the hill.



Liability Reduction



Botrow kiosks reduce ski resorts liability by requiring customers to accept a waiver before they can purchase a ski pass.

Check with your insurer, as an accepted waiver, should reduce your insurance premiums.



Security



We at Botrow take security very seriously. All components to our system are PCI DSS compliant and no card data is stored on Botrow Servers.
